 - PRINT ALLOTMENT LETTER
 - CLICK UPLOAD DOCUMENTS
 - UPLOAD SSC MARKSHEET AND LEAVING CERTIFICATE
2. Open the website <https://www.lsracheja.org/> , login and complete the application form, pay Rs. 200 registration fees, confirm the application, print a copy of the form and bring it alongwith the documents.
3. Name in the Merit List does not guarantee admission. Admission will be done strictly on the basis of actual physical verification of the original documents. **ADMISSION WILL BE CANCELLED** if any discrepancies in the document, found at any stage during the admission process or thereafter.
4. Report to the college for confirmation of admission by submitting the **Original Documents and payment of fees.**

FYJC ARTS AND COMMERCE QUOTA ADMISSION 2026-27
IN-HOUSE (MJD SCHOOL) AND GUJARATI MINORITY QUOTA (THIRD ROUND)

1. Any student who wishes to take admission through any Quota (In-house /Gujarati Linguistic Minority) need to apply for the said Quota in the Government online portal <https://mahafyjadmissions.in>
2. MINORITY Students should apply for minority quota by selecting APPLY FOR MINORITY QUOTA TAB under Quota choices and select L.S. RAHEJA COLLEGE on Government onlineportal <https://mahafyjadmissions.in>
3. INHOUSE students seeking admission under INHOUSE quota should select the INHOUSEQUOTA TAB option in the Government online portal <https://mahafyjadmissions.in> select L.S. RAHEJA COLLEGE, failing which their application will not be considered under Inhouse quota.
4. ATKT AND REPEATER STUDENTS SHOULD NOT APPLY for IN-HOUSE and GUJARATI QUOTA.
5. For IN-HOUSE QUOTA admission, students should have passed SSC examination from MALATI JAYANTI DALAL SCHOOL in March 2026 only as regular student.
6. For GUJARATI QUOTA, students should have passed SSC or Equivalent examination from Maharashtra State in March 2026 only as regular student & the mother tongue is GUJARATI.
7. College will prepare the Merit list of Quota seat applied by students from the Government online portal <https://mahafyjadmissions.in>
8. Those students whose names appear on the merit list only should register in the website <https://www.lsracheja.org/>, login and complete the application form, pay Rs. 200 registration fees, confirm the application and take printout of the form.
9. Name in the Merit List does not guarantee admission. Admission will be done strictly on the basis of actual physical verification of the original documents. **ADMISSION WILL BE CANCELLED** if any discrepancies in the document, found at any stage during the admission process or thereafter.
10. Students who fail to submit the original documents and pay the fees within the stipulated time period, for any reason, shall lose the claim for admission.
